

# Adult Model Release Agreement

## 1. Controlling Law

The governing law for this Agreement shall be the laws of the State of Oklahoma and the federal laws of the United States of America. This shall expressly exclude the laws of any other state or territory.

## 2. Entirety of the Contract

This Agreement constitutes the entire understanding between the Parties. No modifications shall be valid unless made in writing and signed by both Parties. Oral agreements are expressly excluded.

## 3. Severability

If any term of this Agreement is found to be unenforceable by a court of law, the remainder shall remain in full force and effect.

## 4. Age of Model

The Model represents and warrants that they are at least eighteen (18) years old and will provide necessary documentation (e.g., state-issued photo identification) to comply with 18 U.S.C. 2257 and/or 18 U.S.C. 2257A. Making false statements about age or using forged identification is a criminal offense, and the Producer will prosecute such actions fully. The Model's full date of birth is \_\_\_\_\_ . ## 5. Scope of Video Production

## 6. Scope of Release

The Model grants the Producer the unrestricted, irrevocable, worldwide right to use and publish the videos and/or motion pictures produced, in whole or in part, with or without alterations, for any legal purpose.

## 7. Compensation

The Model agrees to waive any royalties or ongoing compensation. No compensation will be provided if the video production is not reasonably completed by the Model.

## 8. Personal Information

The Producer retains all copyrights to the video production under the United States Copyright Act. The Model has no ownership or intellectual property rights in the video production.

The Producer may sell or assign their rights under this Agreement at any time.

The paragraph numbers and headings are for reference only and do not constitute any part of this Agreement.

**12. Additional Terms**

Grant of Rights The Model grants the Producer, Evoked LLC, and its agents, legal representatives, and assigns the right to use, reproduce, publish, and distribute the images and videos taken during the production for any commercial, promotional, or editorial purposes in any media format. Release of Claims The Model releases all claims against the Producer, Evoked LLC, and any company that buys, uses, or obtains licenses for the images and videos, including but not limited to claims of copyright infringement, defamation, invasion of privacy, and rights of publicity.
